## **Job Description - Program Director**

#### Overview

The Judge Frank M. Johnson, Jr. Institute is seeking a Program Director to join its staff as its programming increases. This is a unique opportunity to join a growing 501(c)(3) organization focused on sharing the stories of history to inspire and promote civics education, and understanding of the United States and its system of government.

This position will report to the Executive Director and will work with him to manage existing programs and develop new educational programming focused on the U.S. Constitution and the independent judiciary.

This role is on a full-time, hybrid basis. The successful applicant will be able to work in person in Montgomery in the regular course of business but may work remotely when needed. Please note that the Johnson Institute is non-partisan and non-political, and it is not an advocacy organization.

# **Roles & Responsibilities**

- Design in-person and virtual educational and educational events throughout the year for a variety of audiences (e.g. students, teachers, attorneys, other professionals, etc.);
- Promote and manage Johnson Institute Scholars conferences for middle and high school teachers;
- Oversee tours of the the Frank Johnson Courthouse;
- Oversee the development and dissemination of written resources for focused on the U.S. Constitution;
- Collaborate with Development Director, Administrative Coordinator, board members, and courthouse staff on other projects and duties as assigned.

### **Qualifications**

- Bachelor's degree required, and Master's degree in a relevant field preferred;
- Minimum 5-7 years of experience in law, education, or a related field preferred;
- Excellent written and verbal communication skills, including the ability to tailor messages and materials to a variety of audiences;
- Knowledge and understanding of some or all of the following topics: civics, law, American history, civil rights, and education;
- Project management or event management experience a plus;
- Ability to think strategically and entrepreneurially as part of a growing organization and operate with curiosity and optimism;
